1. INFORMATION AND SCOPE OF INSPECTION

This section tells you about the type, accommodation, neighbourhood, age and construction of the property. It also tells you about the extent of the inspection and highlights anything that the surveyor could not inspect.

All references to visual inspection refer to an inspection from within the property without the need to move any obstructions and externally from ground level within the site and adjoining public areas. Any references to left or right are taken facing the front of the property.

The inspection is carried out without causing damage to the building or its contents and without endangering the occupiers or the surveyor. Heavy furniture, stored items and insulation are not moved. Unless identified in the report the surveyor will assume that no harmful or hazardous materials or techniques have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

Services such as TV/cable connection, internet connection, swimming pools and other leisure facilities etc. were not inspected or reported on.

Description	Troyhead comprises a detached bungalow with outbuildings. The house is used for entirely residential purposes.
Accommodation	Sitting Room, Kitchen/Dining Room, Sunroom, Three (3nr) Bedrooms, Bathroom, Vestibule, Hall.
Gross internal floor area (m²)	The gross internal floor area is approximately 106m ² .
Neighbourhood and location	The property is situated in a rural location in Shapinsay, which is one of Orkney's north isles. Amenities available in Shapinsay include a Primary School and shop. A short ro-ro ferry service links Shapinsay with Kirkwall, where the full range of services are available. Orkney is well connected to the Scottish Mainland by regular sea and air connections.
Age	The original property is thought to date from the early 1900's; the rear extension was constructed in the mid 1980's, and the front extension was added in 2006.
Weather	The weather was cold with snow showers, following a period of changeable weather. The report should be read in context of these weather conditions.

Chimney stacks

There are 2nr chimney stacks, one to each gable of the original cottage.
Both stacks are rendered, with concrete copes and single clay chimney cans.
Leadwork flashings to the base of the chimneys.

Visually inspected with the aid of binoculars where appropriate.

Roofing including roof space

Pitched timber framed roof structure to the original cottage and rear extension, with plywood sarking and profiled concrete tiles; concrete ridge tiles.
Fibreglass insulation to the ceiling joists.
Flat roof to the front extension, which is clad with fibreglass.

Sloping roofs were visually inspected with the aid of binoculars where appropriate.

*Head and shoulders inspection of the roof space (pitched roof) only.
Flat roofs were visually inspected from vantage points within the property and where safe and reasonable to do so from a 3m ladder externally.*

No access to inspect the structure of the flat roof.

Rainwater fittings

White uPVC square profile gutters and downpipes.

Visually inspected with the aid of binoculars where appropriate.

Main walls

Stone walls to the original Cottage; assumed cavity block walls to the rear extension; cavity block or structural timber frame with block-work outer leaf to the front extension.
External wall insulation has been installed to the entire house (It is understood that this was carried out in 2016).

Visually inspected with the aid of binoculars where appropriate.

Foundations and concealed parts were not exposed or inspected

Windows, external doors and joinery

uPVC double glazed windows of various ages throughout; uPVC fully glazed front door; uPVC half glazed back door.

Internal and external doors were opened and closed where keys were available.

Random windows were opened and closed where possible.

Doors and windows were not forced open.

External decorations

There are no external decorations.

Visually inspected.

Conservatories / porches

The front extension consists of an Entrance Vestibule and Sunroom.
Details included elsewhere.

Visually inspected.

Communal areas

There are no communal areas.

Circulation areas visually inspected.

Garages and permanent outbuildings

There are various outbuildings surrounding the house:

Workshop (to east of house): concrete floor; walls either block built or clad with fibre-cement sheets; mono-pitch roof clad with metal sheeting.

Internal dimensions 7.3m x 7.6m.

Stone sheds (to west of house): flagstone floors; stone walls; pitched roofs clad with flagstones or fibre cement sheets.

Internal dimensions 16.0m x 3.6m and 8.0m x 3.0m.

Garage: concrete floor, shuttered concrete walls; pitched roof clad with fibre cement sheets.

Internal dimensions 5.2m x 3.2m.

Note: the fibre cement sheets to the outbuildings may contain asbestos, depending on their age.

Visually inspected.

Outside areas and boundaries

The house and outbuildings sit within a site with rough grass and an area of bushes/trees and a pond.

The total area of the site is estimated to be around 1.5 acres.

Gravel hardstanding area at the side of the public road and to the west of the outbuildings.

Paving slabs at front door.

Timber decking and balustrade to the Sunroom.

Visually inspected.

Ceilings

Ceilings are lined with plasterboard.

Visually inspected from floor level.

Internal walls

Internal walls and partitions are timber framed and lined with plasterboard.

Visually inspected from floor level.

Using a moisture meter, walls were randomly tested for dampness where considered appropriate.

Floors including sub floors

Solid ground floors.

Surfaces of exposed floors were visually inspected. No carpets or floor coverings were lifted.

There are no sub-floor areas.

Internal joinery and kitchen fittings

Modern fitted units to the Kitchen with preformed upstands. Oak effect window cills with plywood or plasterboard ingoes. Softwood timber finishes.

Pre-finished interior doors to the Bedrooms and Bathroom; glazed doors to the Kitchen/Dining Room, Vestibule and Sitting Room; chrome lever handles.

Built in wardrobes to one Bedroom with prefinished boarded effect doors; built in cupboards to the Hall.

Built-in cupboards were looked into but no stored items were moved. Kitchen units were visually inspected excluding appliances.

Chimney breasts and fireplaces

There is a solid fuel stove in the Sitting Room sitting on a flagstone hearth, with a timber surround.

Visually inspected. No testing of the flues or fittings was carried out.

Internal decorations

Interior walls and ceilings are emulsioned; interior timber finishes are painted.

Panelling to walls and ceiling of the Bathroom.

Stainless steel splashback to the cooker.

Floor coverings consist of laminate to the Sitting Room, Sunroom, Kitchen/Dining Room and Hall; vinyl to the Bathroom; carpet to the Bedrooms.

Visually inspected.

Cellars

There are no cellars.

Visually inspected where there was safe and purpose-built access.

Electricity

The property is served by mains electricity supplies to distribution boards and THTC meters in a cupboard in the Vestibule.

Note: it is understood that the tariff has been changed to a single rate.

Built-in electric oven, grill, dishwasher and extractor fan to the Kitchen.

Extractor fan fitted to the Bathroom.

Accessible parts of the wiring were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.

Gas

There is no mains gas in Orkney.

Gas hob with Calor Gas supply.

Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.

Water, plumbing and bathroom fittings

The property is understood to be connected to the mains water supply. The pipework, where visible, is of copper and UPVC construction.

Sanitary ware includes:

Kitchen/Dining Room – 1.5 bowl stainless steel sink & drainer.

Bathroom – double ended plastic bath, electric shower in cabinet with tray, wash-hand basin, WC.

Visual inspection of the accessible pipework, water tanks, cylinders and fittings without removing any insulation.

No tests whatsoever were carried out to the system or appliances.

Heating and hot water

The property is heated by an external oil combi boiler to the west of the house, heating radiators throughout the house and a towel rail in the Bathroom.

The heating is controlled by a programmer, wall thermostat and TRV's fitted to the radiators.

It is understood that the heating system was installed in December 2018.

Domestic hot water is also supplied from the oil boiler.

Plastic oil tank on concrete base.

Accessible parts of the system were visually inspected apart from communal systems, which were not inspected.

No tests whatsoever were carried out to the system or appliances.

Drainage

The property is assumed to be connected to a septic tank on site.

Drainage covers etc were not lifted.

Neither drains nor drainage systems were tested.

Fire, smoke and burglar alarms

Smoke detectors fitted throughout.

Visually inspected.

No tests whatsoever were carried out to the system or appliances.

NOTE: As per Fire Safety Legislation (effective February 2022), smoke detectors should be installed to the living area and circulation spaces, and a high heat alarm fitted in the Kitchen. CO detectors are also required where required.

Any additional limits to inspection:

At the time of our inspection the property was occupied and fully furnished with floors fully covered throughout.

Pitched roof coverings were inspected from ground level; a detailed inspection of condition was not undertaken.

An inspection for Japanese Knotweed or other invasive plant species was not carried out.

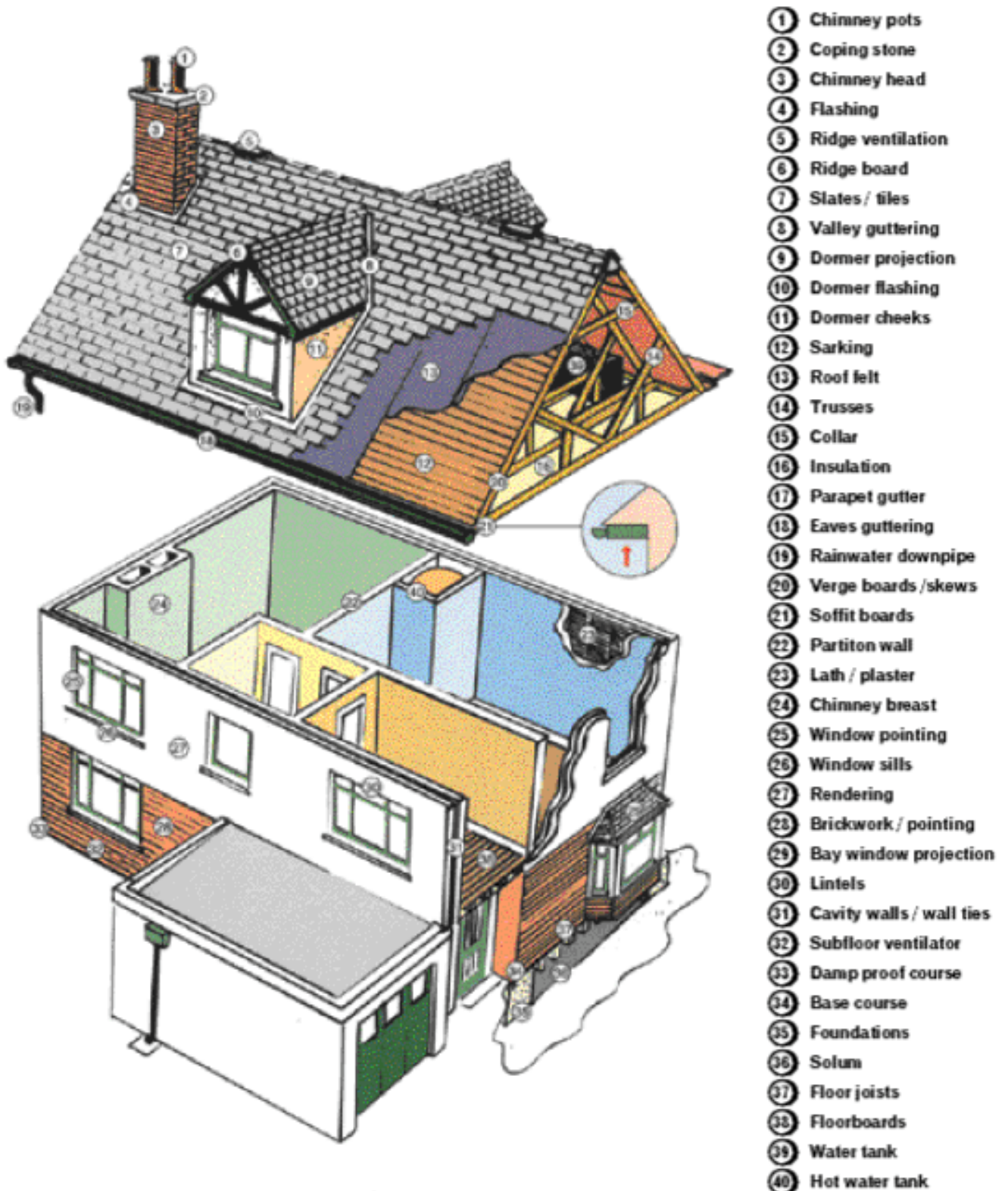
There was no access for inspection to the foundations or behind wall linings.

The drainage system was not open to inspection.

High levels of Radon gas have been recorded in areas of Orkney. No tests were carried out to detect the levels of gas in the property.

This inspection does not determine whether asbestos is present. A qualified asbestos surveyor should be engaged if required.



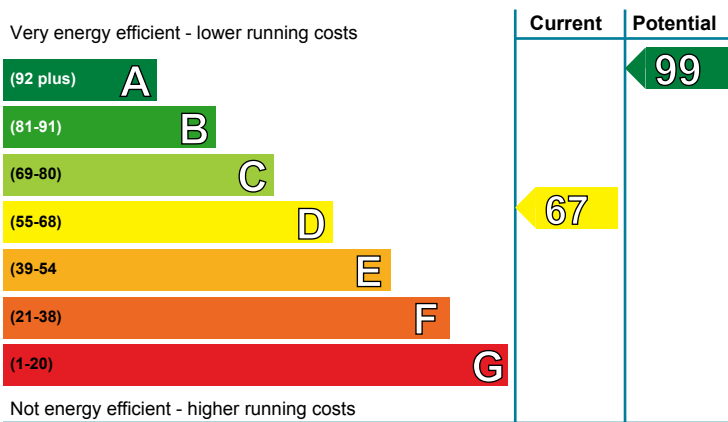

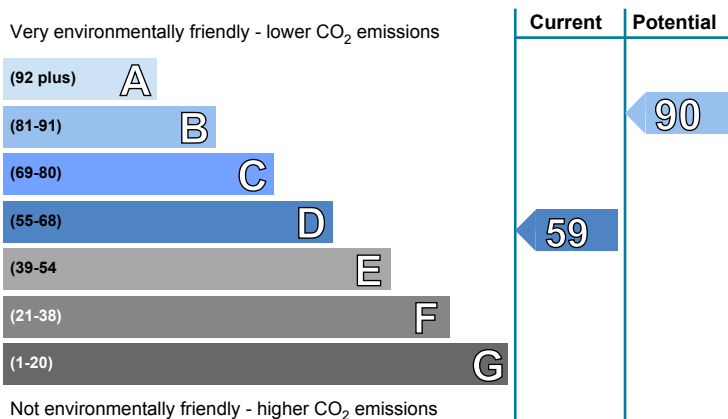

The energy efficiency rating of your home

Your Energy Efficiency Rating is calculated using the standard UK methodology, RdSAP. This calculates energy used for heating, hot water, lighting and ventilation and then applies fuel costs to that energy use to give an overall rating for your home. The rating is given on a scale of 1 to 100. Other than the cost of fuel for electrical appliances and for cooking, a building with a rating of 100 would cost almost nothing to run.

As we all use our homes in different ways, the energy rating is calculated using standard occupancy assumptions which may be different from the way you use it. The rating also uses national weather information to allow comparison between buildings in different parts of Scotland. However, to make information more relevant to your home, local weather data is used to calculate your energy use, CO₂ emissions, running costs and the savings possible from making improvements.


The impact of your home on the environment

One of the biggest contributors to global warming is carbon dioxide. The energy we use for heating, lighting and power in our homes produces over a quarter of the UK's carbon dioxide emissions. Different fuels produce different amounts of carbon dioxide for every kilowatt hour (kWh) of energy used. The Environmental Impact Rating of your home is calculated by applying these 'carbon factors' for the fuels you use to your overall energy use.

The calculated emissions for your home are 50 kg CO₂/m²/yr.

The average Scottish household produces about 6 tonnes of carbon dioxide every year. Based on this assessment, heating and lighting this home currently produces approximately 5.3 tonnes of carbon dioxide every year. Adopting recommendations in this report can reduce emissions and protect the environment. If you were to install all of these recommendations this could reduce emissions by 3.4 tonnes per year. You could reduce emissions even more by switching to renewable energy sources.







1 Floor insulation (solid floor)

Insulation of a floor will significantly reduce heat loss; this will improve levels of comfort, reduce energy use and lower fuel bills. Insulating solid floors can present challenges; insulation laid on top of existing solid floors may impact on existing doors and finishes whilst lifting of a solid floor to insert insulation below will require consideration of the potential effect on both structural stability and damp proofing. It is advised to seek advice from a Chartered Structural Engineer or a registered Architect about this if unsure. 2 Solar water heating

1.1 THE SURVEYORS

The Surveyors are entitled to refrain from delivering the Report to anyone until the fee and other charges for it notified to the Seller have been paid. Additional fees will be charged for subsequent inspections and Reports.

1.6 CANCELLATION

The Seller will be entitled to cancel the inspection by notifying the Surveyor's office at any time before the day of the inspection. /-

The Surveyor will be entitled not to proceed with the inspection (and will so report promptly to the Seller) if after arriving at the property, the Surveyor concludes that it is of a type of construction of which the surveyor has insufficient specialist knowledge to be able to provide the inspection satisfactorily. The Surveyor will also be entitled not to proceed if after arriving at the property, the surveyor concludes that the property is exempt under Part 3 of The Housing (Scotland) Act 2006 as detailed in the (Prescribed Documents) Regulations 2008. If there is a potential threat to their health or personal safety, the inspection may be postponed or cancelled, at the Surveyor's discretion.

In the case of cancellation or the inspection not proceeding, the Surveyor will refund any fees paid by the Seller for the inspection and Report, except for expenses reasonably incurred and any fee due in light of the final paragraph of this section.

In the case of cancellation by the Seller, for whatever reason, after the inspection has taken place but before a written report is issued, the Surveyor will be entitled to raise an Invoice equivalent to 80% of the agreed fee.

1.7 PRECEDENCE

If there is any incompatibility between these Terms and Conditions and the Report, these Terms and Conditions take precedence.

1.8 DEFINITIONS

- the "Lender" is the party who has provided or intends or proposes to provide financial assistance to the Purchaser towards the purchase of the Property and in whose favour a standard security will be granted over the Property;
- the "Market Value" is *The estimated amount for which a Property should exchange on the date of valuation between a willing buyer and a willing seller in an arm's length transaction after proper marketing wherein the parties had each acted knowledgeably, prudently and without compulsion;*
- the "Property" is the property which forms the subject of the Report;
- the "Purchaser" is the person (or persons) who enters into a contract to buy the Property from the Seller;
- a "prospective Purchaser" is anyone considering buying the Property.
- the "Report" is the report, of the kind described in Part 2 of these Terms and Conditions and in the form set out in part 1 of Schedule 1 of the Housing (Scotland) Act 2006 (Prescribed Documents) Regulations 2008;
- the "Seller" is/are the proprietor(s) of the Property;
- the "Surveyor" is the author of the Report on the Property; and
- the "Surveyors" are the firm or company of which the Surveyor is an employee, director, member or partner (unless the Surveyor is not an employee, director, member of partner, when the "Surveyors" means the Surveyor) whose details are set out at the head of the Report.
- the "Energy Report" is the advice given by the accredited Energy Company, based on information collected by the Surveyor during the Inspection, and also includes an Energy Performance Certificate, in a Government approved format.

PART 2 – DESCRIPTION OF THE REPORT

2.1 THE SERVICE

The Single Survey is a Report by an independent Surveyor, prepared in an objective way regarding the condition and value of the Property on the day of the inspection, and who is a member of the Royal Institution of Chartered Surveyors. It includes an Energy Report as required by Statute and this is in the format of the accredited Energy Company.

2.2 THE INSPECTION

The Inspection is a general surface examination of those parts of the Property which are accessible: in other words, *visible and readily available for examination from ground and floor levels, without risk of causing damage to the Property or injury to the Surveyor.*

All references to visual inspection refer to an inspection from within the property at floor level and from ground level within the site and adjoining public areas, without the need to move any obstructions. Any references to left or right are taken facing the front of the property.

The Inspection is carried out with the Seller's permission, without causing damage to the building or contents. Furniture, stored items and insulation are not moved.

Unless identified in the report the Surveyor will assume that no harmful or hazardous materials have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

The Surveyor will not carry out an asbestos inspection, and will not be acting as an asbestos inspector in completing a Single Survey of properties that may fall within the Control of Asbestos in the Workplace Regulations. In the case of flats it will be assumed that there is a duty holder, as defined in the Regulations and that a Register of Asbestos and effective Management Plan is in place, which does not require any expenditure, or pose a significant risk to health. No enquiry of the duty holder will be made.

2.3 THE REPORT

The Report will be prepared by the Surveyor who carried out the property inspection and will describe various aspects of the property as defined by the headings of the Single Survey report with the comments being general and unbiased. The report on the location, style and condition of the property, will be concise and will be restricted to matters that could have a material effect upon value and will omit items that, in the Surveyors opinion, are not significant. If certain minor matters are mentioned, it should not be interpreted that the property is free of any other minor defects.

Throughout the report, the following repair categories will be used to give an overall opinion of the state of repair and condition of the property.

2.3.1 Category 3: Urgent repairs or replacement are needed now. Failure to deal with them may cause problems to other parts of the property or cause a safety hazard. Estimates for repairs or replacement are needed now.

2.3.2 Category 2: Repairs or replacement requiring future attention, but estimates are still advised.

2.3.3 Category 1: No immediate action or repair is needed.

WARNING: /-

WARNING: If left unattended, even for a relatively short period, Category 2 repairs can rapidly develop into more serious Category 3 repairs. The existence of Category 2 or Category 3 repairs may have an adverse effect on marketability, value and the sale price ultimately achieved for the property. This is particularly true during slow market conditions when the effect can be considerable. Parts of the property, which cannot be seen or accessed, will not be reported upon and this will be stated. If the Surveyor suspects that a defect may exist within an unexposed area and which could have a material effect upon the value, he may recommend further investigation by specialist contractors.

2.4 SERVICES

Surveyors are not equipped or qualified to test the services and therefore no comment can be interpreted as implying that the design, installation and function of the services are in accordance/compliance with regulations, safety and efficiency expectations. However, comment is made where there is cause to suspect significant defects or shortcomings with the installations. No tests are made of any services or appliances.

2.5 ACCESSIBILITY

A section is included to help identify the basic information interested parties need to know to decide whether to view a property.

2.6 ENERGY REPORT

A section is included that makes provision for an Energy Report, relative to the property. The Surveyor will collect physical data from the property and provide such data in a format required by an accredited Energy Company. The Surveyor cannot of course accept liability for any advice given by the Energy Company.

2.7 VALUATION AND CONVEYANCER ISSUES

The last section of the Report contains matters considered relevant to the Conveyancer (Solicitor). It also contains the Surveyor's opinion both of the market value of the property and of the re-instatement cost, as defined below.

Market Value "The estimated amount for which a property should exchange on the date of valuation within a willing buyer and a willing seller in an arms-length transaction after proper marketing wherein the parties had each acted knowledgeably, prudently and without compulsion." In arriving at the opinion of the Market Value the Surveyor also makes various standard assumptions covering, for example, vacant possession; tenure and other legal considerations; contamination and hazardous materials; the condition of un-inspected parts; the right to use mains services; and the exclusion of curtains, carpets etc from the valuation. In the case of flats, the following further assumptions are made that:

- *There are rights of access and exit over all communal roadways, corridors, stairways etc and to use communal grounds, parking areas, and other facilities;
- *There are no particularly troublesome or unusual legal restrictions;
- *There is no current dispute between the occupiers of the flats or any outstanding claims or losses; and the costs of repairs to the building are shared among the co-proprietors on an equitable basis.

Any additional assumption, or any found not to apply, is reported.

"Re-instatement cost" /-

TERMS AND CONDITIONS

"Re-instatement cost" *is an estimate for insurance purposes of the current cost of rebuilding the Property in its present form* unless otherwise stated. This includes the cost of rebuilding the garage and permanent outbuildings, site clearance and professional fees, but excludes VAT (except on fees).

Sellers or prospective Purchasers may consider it prudent to instruct a reinspection and revaluation after a period of 12 weeks (or sooner if appropriate) to reflect changing circumstances in the market and/or in the physical condition of the Property.
